Ref: This office letters of even number, dated: 15.06.2020 & 16.05.2018.

In supersession of the above referred letter, the tariff of Railway Officers' Rest House over South Central Railway for serving/retired officers and Railway Officers on Deputation/Absorbed in PSUs have been as follows:

\$ In case of working Railway Officers/Retired Railway Officers, who wants ORH room "Other than On Duty" for herself/himself or her/his family (as per pass rules), tariff applicable is as per "On Private Account".

Restriction for number of Guest days booking by individual Officer in a financial year :

- 1) No restriction for DRMs, PHODs and GM Secretariat Officers.
- 2) For other Officers, it will be limited to 30 guest days in a financial year. If any officer requires booking for more than 30 guest days, the Officer shall obtain prior approval of DRM in case of Divisional officers and approval of PHOD in case of Non-Divisional officers.

4. Booking of ORH to South Central Railway Officers in service, for self / family (as per pass rules) at the location (City / Town) where present residential accommodation of the Officer and ORH is same.**4.1 Eligible grounds**

- 4.1.1 Medical exigencies
- 4.1.2 Residing in Railway Quarters but it is taken up for unexpected partial repairs.
- 4.1.3 Inundation during floods, fire and other natural calamities in the a) Private accommodation
b) Railway accommodation.
- 4.1.4 Riots / curfew / inundation of roads due to floods and other force majeure causes in the route between office and officer's present house.

4.2 Allotment rules for the grounds at Para 4.1:

- 4.2.1 Medical exigency: It means, the officer / family (as per pass rules) requires frequent medical attention from Railway Hospital or referral hospital, which is located near to ORH for which the medical expert who is treating the officer / family (as per pass rules) has given his/her recommendation.
- 4.2.2 Railway quarter taken up for unexpected partial repairs: Letter from ADEN/DEN concerned indicating the repairs with start date and likely period of completion.
- 4.2.3 Request for allotment on the above ground(s) (Para 4.1.1 to 4.1.4) should be made with prior approval of PHoD/CHoD/DRM of the concerned Department and submit to ORH allotment authority with requisite documents as mentioned in sub-para 4.2.1/4.2.2/any other Railway Board letter. In case of requirement for PHoD/DRM, self certification with a recommendation / letter from the authority at Para 4.2.1 /4.2.2 is sufficient.
- 4.2.4 Allotment on the above grounds is normally limited to not more than 30 days. In case of any further requirement, the procedure as mentioned above (in para 4.2.1 to 4.2.3) needs to be repeated for every 30 days extension.
