DRAFT NOTIFICATION FOR TRC NO.3 of 2020  
(GOODS)**

**Sub: No Haulage Charge for movement of empty containers and empty flat wagons.**

Please refer to Corrigendum No.2 of Rates Circular No.20 of 2018 vide which it has been decided to grant 25% discount on extant 'Haulage Rate per TEU' for movement of empty containers and to grant similar 25% discount on extant 'Haulage Rate per TEU' for movement of empty flat wagons. These instructions are valid upto 31.03.2020 as per Corrigendum No.3. Vide E-office No. 3316118 dated 23.03.2020, the validity of these instructions have been extended upto 30.04.2020.

In partial modification of aforesaid instructions, competent authority has decided that **no Haulage Charge** will be levied for movement of empty containers and, similarly, **no Haulage charge** will be levied for movement of empty flat wagons, **from 24.03.2020 till 30.04.2020.**

This issue with the concurrence of Finance Directorate of Ministry of Railways.
