Further to this office notification cited for filling up of 2 (UR-2, SC-Nil, ST-Nil) vacancies of ACM, a list consisting of 184 (One hundred and eighty four only) names of employees who have applied for selection to Group 'B' post of Assistant Commercial Manager in Level-8 of 7th CPC Pay Matrix against 30% LDCE Quota in Commercial Department and found eligible for the same is enclosed as "Annexure-I".

All the controlling officials are advised to note and notify the list to all the eligible employees working under their control and advise the eligible employees to be in readiness to appear for Written Examination in the form of Centralized Computer Based Test (Objective type) to be conducted by DG/NAIR on 23.06.2024.

If any of the employees mentioned in the eligibility list (Annexure-I) are on leave/ training/deputation/sick or working in any other unit, intimation should be sent to their place of working/personal address and their acknowledgment obtained and a copy of which shall be forwarded to this office for record. The employees may be advised that no supplementary written examination (CBT) will be conducted under any circumstances.

The Syllabus as well as the distribution of marks for the Written Examination (CBT) was already advised in the Notification, dated 20.03.2024. As already mentioned in the notification. the CBT will consist of 175 questions, of which 150 are required to be answered. Each Question will carry one mark. One third of the marks will be deducted for every wrong answer.

The Duration of the Written Examination (CBT) will be 3 (three) Hours and qualifying marks to be called for viva-voce will be 90 marks. However, in case more than 10 candidates (i.e. 5 times of the vacancies) qualify in the written examination, 10 candidates will only be called for the viva-voce in the order of their merit. However, in case two or more candidates score equal marks in the exam and tie for the last spot, all of them will be called for viva-voce.

The Time and Venue(s) of the examination together with any other instructions related to the written examination through CBT will be intimated shortly.
