The competent authority has decided to conduct the written examination to other eligible employees, in addition to those employees who had appeared and got qualified in written examination held in pursuant to the Interim Orders granted by Hon'ble High Court of Andhra Pradesh in WP.No.15119 of 2023. Therefore, the employees mentioned at Annexure –A & B who were eligible as per the notification dated 18.12.2018 are hereby alerted to be in readiness for attending written examination scheduled at 14.00 hrs on 16.12.2023 at ETTC/BZA for the post of Ticket Examiner in level-3 in 7th CPC pay matrix.

All the employees should note that the competent authority reserves the right to take stringent action/appropriate departmental proceedings against any malpractices against the employees who would commit any malpractices of minutest kind also and which means and includes debarring such a candidate.

The selection consists of written test and record of service. The written examination will be based on old syllabus. The syllabus for the written examination is enclosed as **Annexure**—C. The selection procedure in vogue will be adopted at the time of notification.

The question paper will be 100% objective type and of multiple choice only. The examination will be conducted on OMR sheet. 10% of the total marks will be from Official Language policy as per extant rules, which will be optional. There will be no negative marking for wrong answers. Cutting, overwriting, marking more than one answer, erasing, whitening or any type of alterations in the OMR will not be accepted and zero marks will be given for answers having such correction/over writing.

The candidates are not allowed to carry mobile phones and any other materials such as Electronic gadgets, course material etc., with them in the examination hall except relief letter. Disciplinary action will be initiated against them, if found indulging in unfair means and further debarring such candidates for future selections.

There will be no supplementary written test under any circumstances. As such the above employees should appear without fail.

Those who qualify in the written examination have to pass the medical test for Bee-Two classification, which is pre-requisite for empanelment. The promotion of empanelled candidates will be subjected to the prescribed training at ZRTI/MLY. Only on successful completion of training, they will be promoted.

If any changes/corrections in the details of the above employees is noted, the same may be brought to notice of undersigned immediately for necessary rectification.

All the In-charge/Supervisory officials of previous stations as well as present stations are hereby advised to notify the above contents of this letter to all the above named employees under their clear acknowledgements. Also, if, any of the above employees are on leave/sick/training the information should be sent to his leave/sick/residential/training address duly obtaining their acknowledgement and the same may be sent to this office. Also a copy of this letter should be placed on station notice boards concerned. The Incharge/Supervisory Officials are responsible to make necessary arrangements in place of the above employees, in order to relieve them in time.

It is the prime responsibility of the In-charge/Senior supervisory officials concerned to intimate the contents of this letter to all the eligible employees and their relief.
