The above promotion is provisional and subject to the condition that:

1. He is free from DAR/SPE/Vigilance cases.

2. Not undergoing any penalties debarring from promotion, not under suspension.

3. Outcome of cases pending before Hon'ble/Tribunals/Hon'ble High Court/Hon'ble Supreme Court of India.

The date of assuming higher grade responsibility by the above employee should be advised to all concerned. He will be on probation for a period of 12 months and his continuance in the higher grade will be subject to his successful completion of probation.

He should vacate the Railway Quarters if any under his occupation and handed over Railway property if any under his possession to the concerned supervisors before he carry out the transfer orders. He should be relieved immediately and the date of his relief at old station and date of joining at new station should be advised to all concerned. He is eligible for transfer benefits on transfer account.
