Strategy to implement 2x25 kV up-gradation work and planning for balance electrification with CORE & wayforward.

The present electrification works with project units of CORE is coming to an end and no new work has been allotted to CORE. 2x25 kV electric traction up-gradation work has been included approved in the Pink Book 2023-24 as an umbrella work and magnitude of this work is huge. It has been decided by Board (MI, MTRS and CRB & CEO) that 2x25 kV up-gradation work over IR shall be executed by the Zonal Railways through CEE/Project.

The framework for transfer of units from CORE to Zonal Railways to implement 2x25 kV upgradation work is as under:

Balance 75% of the Gazzetted as well as Non-Gazzetted man power of the units proposed for transfer to Zonal Railways shall report to PCEE of the concerned zonal Railway for execution of targeted 2x25 kv electric traction upgrdation work as per sanctioned umbrella work, leftover works/ drawing completion report/post contractual issues of 1x25 kv electrification works of RE projects and maintenance & upkeep of newly created electric traction infrastructure assets.

Zone wise distribution of Gazzetted manpower (Electrical, Signal & Engineering) is attached as Annexure. Zone wise Distribution of Gazzetted manpower of other Departments and Non-Gazzetted manpower of all Departments shall be done in the concerned Zone of the Unit.

- 3. The transfer orders for Gr. A Gazzetted officers to implement the above; shall be issued by Rly Board. The transfer orders for Gr. B &Non-Gazzetted officials shall be issued by GM/CORE as per above timelines with intimation to Railway Board.
