- c) final outcome of ongoing litigations/court cases on the subject and any other cases pending before various courts of law
- d) subject to outcome of OA No.020/357/2018 filed before Hon'ble CAT/HYB.

They are eligible for drawl of B/pay in higher level i.e.in Level-7 from the date of shouldering higher responsibilities as CTI. The date of assuming higher grade responsibilities by the employees should be advised to all concerned. They will be on probation for a period of 12 months and their continuance in the higher level will be subject to their successful completion of probation. The employee at SI.No.1 is eligible for transfer benefits.

The above employees can exercise option for fixation of pay from 01.07.2020 i.e. from the date of accrual of increment in lower grade under FR 22 1(a)(1) and such option should be submitted to this office within one month from the issue of this office order.
