Sub: Conversion of SBI Point of Sale (PoS) machines from Standalone Mode to Integrated Mode – Reg.

Ref: Rly Board's lr. no. 2021/TG-I/10/P/Standalone PoS dt. 10/08/2021.

Railway Board vide letter under reference has instructed that the SBI Point of Sale (PoS) machines installed in the **PRS/UTS networks** have to be converted from the Standalone Mode to Integrated Mode **by 30/09/21**. Further, it is advised that the UTS & PRS application of the Standalone PoS machines will be disabled **by CRIS** (Boards ltr. enclosed).

Despite several efforts made by the PRS & UTS Database teams, the PoS machines available at various PRS & UTS locations could not be reconciled for want of information from the field staff.

It is this regard it is instructed to furnish the following latest information immediately to this office, so as to apprise the same to H.Qrts for reconciling the data and to initiate integration in coordination with CRIS & SBI.

Sub: Convert POS working in standalone mode to integrated mode and disabling of Standalone POS.

Please find enclosed a copy of CRIS' letter No. 2017/CRIS/NDLS-HQ/UTS/PROJECT/253/0240 dated 05.08.2021 regarding the conversion of POS working in standalone mode to integrated mode and disabling of Standalone POS. At present in standalone POS, booking clerk has to feed amount manually and after swiping of card & printing of charge slip, RRN number & other details has to be fed in system. To stop manual feeding of amount, RRN number & other details, integration of POS devices was done with State Bank of India. In integrated mode, POS device is automatically fetching amount from application and after printing of charge slip, payment confirmation details is automatically sent by SBI to CRIS server.

2. In view of above, it is desired that all remaining standalone POS to may be migrated to integrated mode in coordination with SBI. This exercise of migration of standalone POS to integrated mode may be done positively by 30.09.2021. The details of POS working in Integrated & Standalone mode in UTS and PRS is enclosed.
3. CRIS may disable ticketing in UTS & PRS application from standalone POS w.e.f. 01.10.2021.
