

Off late, there is increase in Rail Madad Complaints regarding unauthorized passengers travelling in reserved coaches. In this regard, PCCM has expressed concern and suggested to conduct drive against unauthorized passengers travelling in reserved coaches. As such, joint drive on unauthorized passengers travelling in reserved coaches to be conducted from **01.02.24 to 07.02.24** over jurisdiction of South Central Railway. In this regard, the following instructions are issued:

- 1) The list of 30 trains wherein on an average one or more complaints are registered per day in this financial year is enclosed. Divisions to control unauthorized passengers travelling in reserved coaches in all major/popular trains, with special emphasis on the train list enclosed.
- 2) Divisions after identifying the trains should invariably arrange to de board the unauthorized passengers at originating station itself before departure of the train and at the major en route stations duly deploying adequate **RPF personnel & ticket checking staff**.
- 3) If any unauthorized passenger is found in train after departure, Amenities/squad staff should charge them up to point of detection and detain at next station, duly coordinating with Commercial control.
- 4) The entry of Season tickets into reserved coaches to be regulated and action to be taken as per extant rules.
- 5) Cases under section 155 of Railway Act to be booked to act as deterrent on irregular travelers.

After completion of the drive, report in the format enclosed to be sent to this office, so as to apprise PCCM.
