1. S.C.Rly.,Employees' Co-op. Credit Society Ltd., Secunderabad, is pleased to sanction the scholarships for the following courses for the academic year 2022-23, subject to availability of funds.

| 5 | B.Pharma, Ag.B.Sc, Students under CA Articleship | Rs.3,000/- |
| 6 | PG, Engg and Medical Courses, MBA, MCA, Fashion Technology | Rs.6,000/- |
| 7 | Ph.D | Rs.8,000/- |
| 8 | Physically, Mentally disabled children (for students only) to only one child every year | Rs.5,000/- |

In addition to the above, merit scholarships will be granted to the above courses as follows:

Note: No separate application is required. Merit awards will be granted along with the regular scholarship.

2. Applications for award of fresh scholarship should be submitted in the prescribed form to "The Secretary, S.C.Rly.,ECCS Ltd/SC, Welfare Fund Committee" duly certified by the Controlling Officer of the employee and the Principal of the concerned College/Institution where the ward is studying as provided in the form on or before 31st March 2024.

3. The Departmental Forwarding Officers are requested to ensure that the particulars mentioned in the application form of the employee are correct and as per the information available in the Railway records.

4. The employee should be a member of the Society during the Academic Year (2022-23) and during the period of course and claim.

Eligibility conditions:

1. The Scholarship shall be awarded only to Sons/daughters of the shareholders and staff of the Society.
2. The student should have successfully completed any of the above courses during academic year 2022-23 in first attempt. Marks memos certified by School/College Principal to be enclosed with application form.
3. Engineering and other courses (wherever semester system is applicable) the students must enclose attested copies of marks memos of two semesters. Students passing the backlog subjects of the Ist semester in the IInd semester of the same academic year are also eligible for scholarships.
4. No shareholder can draw scholarship at a time for more than one child.
5. The Committee will consider for fresh sanction of scholarships strictly based on the marks in the respective qualifying examination in the first attempt.
6. The scholarships will be granted on declaration by the employee that no child of the applicant has obtained scholarship from a "Govt. college or Recognized University or "Free ship" or "Exemption" from paying tuition fees.
7. The decision of the Committee in regard to the award of Scholarship will be final in all respects and no correspondence on the subject will be entertained.
8. If it is found that any applicant has obtained the grant by making false declaration or submitting false certificates, the amount paid shall be recovered from him. The applicant may also render himself liable for disciplinary action.
9. Applications which do not contain complete information are liable to be rejected.

10. A Xerox copy of Society pass book, current month attested pay slip, Bank account Xerox copy should be enclosed to the scholarship application.
11. The Society reserves the right to withhold the award of Scholarship without assigning any reason.
12. Shareholder should enclose the following documents with the Scholarship application.
 - a) Scholarship application form duly forwarded by school/college.
 - b) Xerox copy of Marks memo attested by School/College Principal where the ward is presently studying.
 - c) Xerox copy of Society Pass Book self attested
 - d) Xerox copy of Bank Pass Book of Shareholder, self attested.
 - e) Xerox copy of Office ID Card-cum-Medical Card/ family declaration, self attested.
 - f) Self attested SSC Marks Memo mandatory for sanction of scholarship for any course.
