Sub: Station specific QR codes for obtaining unreserved tickets through "UTS" mobile app – Displaying at all Stations in the booking area – Reg.

Ref: GM/SCR's Inspection notes, dt. 05/11/2022 (copy enclosed).

A copy of the reference cited is enclosed herewith. During the inspection of GM on NED Division on 25/9/2022, it was noticed that QR codes for obtaining tickets through "UTS" mobile app were not available at some of the Stations. It is reiterated that station specific QR codes through which a passenger, who is also in the station premises can obtain tickets through "UTS" mobile app should be displayed conspicuously at various places in the booking area at all Stations without fail.

These station specific QR codes have already been shared with the Divisions earlier and are also made available in the relevant folded in the CCM server. In case of any clarifications/requirement, Stations concerned may contact the Console/UTS database at Headquarters. Compliance on the above may be advised by 15/11/2022 so as to furnish reply to Para No. 4.02 of the GM's inspection note referred above.
