Sub:.. Filling up of vacancies of Commercial Inspectors/HQrs. in Level 7 & Level 6 of VIIIth CPC Pay Matrix. 2016

The following orders are issued with the approval of competent authority to take with immediate effect, subject to the following conditions:

- i) Their postings in PCM office is tenure basis
- ii) They will be repatriated to parent cadre in case their performance is not satisfactory as evaluated by PCCM during period of working irrespective of tenure period worked without further notice.
- iii) They will be repatriated at least SIX months prior to their superannuation.
- iv) In respect of item (1) & (2) these orders will not give any prescriptive right to continue on SC Rly in case of bifurcation of zone and they will be repatriated once new zone SCOR comes into operation.
- v) In respect of item (1) & (2) employees are eligible for transfer benefits, since their transfers issued on administrative grounds.




