The financial up gradation under the MACP Scheme in favour of the above named employees are granted subject to the following conditions.

1. The MACP Scheme envisages only placement in the next higher grade pay in the hierarchy of the revised Pay Band and Grade pay as per section -I, part-A of the first schedule of the Railway services (revised pay) Rules -2008.
2. The financial up gradation under the MACP is purely personal to the employees to whom it is granted and shall have no relevance to their seniority position.
3. The above employees shall retain their designation, status and duties.
4. They should be free from DAR/SPE/Vig.Cases as on the date of conferment of financial up-gradation.
5. At the time of actual promotion if it happens to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be made available.
6. The above employees are eligible for financial and certain other benefits which are linked to the pay drawn by an employee such as HBA, allotment of Govt. accommodation etc., pay drawn in the terminal benefits in respect of retiring employees.
