From the reports related to HHTs utilization available on URL https://hht.indianrail.gov.in/Report ModuleNew/, it has been observed that out of 9974 HHT devices supplied across all Zonal Railways, as on 11.08.2022 only 9304 HHT devices are registered in HHT server and 670 HHTs are yet not registered. Further, only 8031 HHTs are being utilized so far for ticket checking in various trains and 1943 HHTs have yet not been used even once. The copy of zone-wise active device report is enclosed herewith for ready reference.

Since the working of HHT devices is being monitoring at Apex level in Board's office, it is, therefore, requested to kindly look into the matter personally and direct concerned officials to ensure 100% utilization of HHT devices provided over your Railway and ensure that TTEs to whom HHTs have been given, should do ticket checking through HHT device.
