Sub: Handing over of receipt portion of Bank remittance Challan with CR Notes and other vouchers to Commercial Courier – Reg.

In view of closure of financial year 2022, it is necessary that the cash collections of stations are taken into account for the current financial year 2021-22. It may be noted that 01-04-2022, 02-04-2022 and 03-04-2022 are bank holidays. Hence, to enable clearance of DDs/BCs from 25-03-2022 to 31-03-2022 (earning dates), it is advised to remit DD/BCs to Cash Office/BZA or SC instead of local deposit accounts for the earnings pertaining from 25-03-2022 to 31-03-2022.

In view of the above, it is proposed for movement of Commercial Couriers on 01/02-04-2022 in the sections for collection of CR Notes (upto the date TR challans are received) and VR notes upto 31-03-2022 to enable to handover the same at Cash Office, BZA for movement to FA & CAO/T/O/SC. It is advised to handover the SN2 and other monthly statements for the month of March 2022 also along with these CR Notes and VR Notes.

- 1. At stations where SBI Cash Pickup scheme is in progress, arrange to handover CR Notes upto the dates for which TR challans acknowledgements are received at the stations.
- 2. At stations where SBI Cash Pickup scheme is not yet commenced, arrange to handover cash with CR Notes upto 31-03-2022.
- 3. Arrange to handover VR Notes with vouchers upto 31-03-2022 at all the stations, locations, goods sheds and sidings over the division.
- 4. Arrange to handover SN2, Monthly reports and other statements at all the stations for the month of March 2022.

The movement of Commercial Couriers will be as under:

- b) T. No. 07264 ex.COA to BZA leaving COA at 04.10hrs of 02-04-2022.
