

The subject issue has been examined in consultation with Pay Commission Directorate of Railway Board. It has been observed that in terms of instructions contained in Board's letters No. E(W)2018/PS5-1/8 dated 31.01.2019 and 26.07.2019, Pass entitlement of a Railway Servant is to be determined on the basis of his/her "Status cum PLPM". Accordingly, Gazetted Officers working in PLPM-12 are entitled to 1-AC Authority on Duty.
