Indian Railway Catering and Tourism Corporation Ltd. (IRCTC) is a Public Sector Enterprise under Ministry of Railways. IRCTC is the extended arm of the Indian Railways to upgrade, professionalize and manage the catering and hospitality services at stations, on trains and other locations and to promote domestic and international tourism through development of budget hotels, special tour packages, information & commercial publicity and global reservation systems.

Applications are invited from retired Railway Employees (only normal retired persons) for engagement as consultant (Civil Engineering) to work in Catering deptt. under SCZ for setting up/renovate Kitchen Units on consolidated remuneration basis. Details are specified in Annexure-I.

GENERAL CONDITIONS:

- 1. Engagement of Consultants will be on full time / Shift basis.
- 2. Railway employees who are compulsory retired or removed or dismissed from services are not eligible.
- 3. Age limit: Between 60 years to 62 years.
- 4. Remuneration: a maximum 100% of (Last pay drawn +DA Pension + DR)
- 5. Leave, Travelling Allowance etc will be as per IRCTC policy applicable from time to time.
- 6. The period of contract will be initially for a period of Six months which may be extended further upto a period of 6 months depending upon the requirement and overall performance of the individual.
- 7. Mere fulfilling of eligibility criteria shall not confer any right to the applicant for being called for the interview/selection process.
- 8. IRCTC reserves the right to cancel / restrict /modify /alter the engagement process, if need so arises, without issuing any further notice or assigning any reason whatsoever.
- 9. Furnishing of wrong/false/incomplete/inconsistent/ ambiguous information in the application will lead to disqualification of the candidate and his/her candidature will be rejected.
- 10. Any canvassing directly or indirectly by the applicant will disqualify his/her candidature.
