For existing UTS applications in thin clients, character user interface (CUI) is provided for ticketing with database administration (DBA) applications for supervisor for defining operator, agents, bin management, station coaching balance sheet, accounting and MIS reports. However, with the ongoing UTS Modernization, the above applications will be switched to graphical user interface (GUI) which requires augmentation of network bandwidth.
