#### **Tender Guidelines**

#### **Service Level Agreement (SLA)**

During the warranty period, support shall cover 24 hours x 7 days a week at divisions. All types of problems in dynamic QR display device should be attended at divisions within 24 hours from the date of lodging of the complaint by division HQ and problem should be rectified within 2 days from the date of lodging of the complaint. Railways shall make arrangement to make the defective device available at the division HQ which will hand over to vendor for repair/replacement. After repair/replacement, QR display device should be tested through a test application provided by CRIS.
