Setting up shops in trains

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI KOTLA JAYA SURYA PRAKASH REDDY)

(a) to (d): A pilot project for on-board shopping was initiated on experimental basis for a period of one month on a few selected Shatabdi express trains originating from New Delhi for sale of items related to travel, souvenir etc. to explore the potential of onboard shopping facility as a passenger amenity to enable the Railways to conceive a policy on this based on outcome of the above pilot project.
