INTRODUCTION OF ac 25 kV TRACTION

"WARNING TO ROAD USERS"

It is notified for information of the public that in connection with introduction of 25 KV AC Electric Traction over the sections Vijayawada – Gudivada- Bhimavaram Junction – Narasapur, Bhimavaram Junction- Nidadavolu, Bhimavaram Town- Nidadavolu, Gudivada – Machilipatnam of Vijayawada Division of South Central Railway, height gauges have been erected at all the level crossings clear maximum height 4.78m above road level with a view to prevent loads of excessive height from coming into contact or dangerous proximity to "LIVE" traction wire (contact wire), which shall be at a height of minimum 5.5 m above the rail level at level crossings.

Public are hereby, notified to observe the height specified above for the purpose of loading vehicles and to see that the loads carried in road vehicles do not infringe the height gauges under any circumstances.

The dangers of a load of excessive height are as follows: -

- i) Danger to the height gauge and consequent obstruction to the Road as well as the Railway lines.
- ii) Danger to the materials or equipments carried out or the vehicle itself.
- iii) Danger of fire and risk of life due to contact with or dangerous proximity to the conductors.
