With reference to the above subject it is noticed that UTS journey tickets and platform tickets are tampered and the manual entry of fare destination are written in ink and also such altered tickets were being issued to passengers between DNR and DDU stations.

So in this connection the ticket checking staff are advised to look into such aspects during checking on trains and at stations, and concentrate on trains coming from such stations /routes. Therefore it is instructed that the concerned ticket checking staff should detect such type of cases to curb fraudulent activities

During ticket checking, WCR PCCM squad in the Train no 12296 on date 29.09.2022, a case of travel on old UTS ticket and plateform ticket having manual entry of fare and destination by pen has detected.

On asking from the group of passenger travelling in unreserved coach, it is intimated that the tickets were given by ticket checking staff and police between Danapur and Deen Dayal upathayay station. All the authorized passenger have been charged through EFR.

In another similar case, during the ticket check on date 23.09.2022 in train no 12296, some passenger shown EFT from DNR to DDU which have altered manually by pen as destination SBC station. The have explained that EFT was checked by DDU ticket checking staff and police, have collected penalty and altered destination as SBC.

Checking staff of PCCM squad charged the passengers as per extant rule and brought whole incident to the notice of this office.

In view of above, it seems that an organized group may active at DNR, DDU, PRYJ and PCOI stations and dealing of fake tickets.

Therefore, it is suggested that the concerned officers and ticket checking staff may be instructed to detect such type of fraud during ticket checking to curb such type of cases.
