Sub: Proliferation of Parcel Management System on all stations of Indian Railway upto A-I, A and B category.

I. The status of implementation of Parcel Management System on South Central Railways is as follows:

Regarding replacement of PMS equipment at Phase-I locations, this office, vide letter of even No. dated 08.02.2021 advised the Divisions to process for the same in LSWP 2021-22 under PH-1700. Supply of PMS consumable items for phase-I locations for one year has been done by Head quarters office with Dy.CMM/G&S, Mettuguda.

II. Regarding implementation of PMS at Phase-II locations, Sr.DCM/GTL was advised vide this office letter of even No. dated 24.02.2021 that CRIS shall provide the networking, hardware equipment and consumable items and Division must ensure identification/preparation of site at parcel offices by July 2021. All the four parcel offices in Phase-II are located in GTL Division only.

III. CAO/PIS, vide letter dated 22.02.2021 cited at reference (2) above informed that the time line for implementation of PMS at the Phase-III locations (PPMS) is by the **end of September 2021**.

In this connection, CAO/PIS, vide letter dated 17.02.2021 cited at reference (1) above informed that **PPMS** implementation shall not be done centrally by CRIS. The breakup of the items to be procured by CRIS and by the Divisions is as follows:

1. By CRIS under "Capital (DF-3)" estimates

- a. Thin client along with 20% spare
- b. UPS along with 20% spare
- c. Networking equipment at stations at the identified 86 locations

2. By Divisions under "Revenue" estimates

- a. Electronic weighing scale – weighing of parcel packages
- b. Parcel way Bill printers (24 pin 80 column) – generation of PWB and LT
- c. Barcode printers – printing of Barcode labels to be pasted on packages
- d. Report generation printers (9 pin 136 column) – generation of accounting report
- e. Mini Printers – generation of loading summary SLR/VPU wise
- f. Hand Held Terminals – for reading of barcode on loaded and unloaded packages
- g. Consumables like PWB stationery, Barcode labels, Barcode ribbons and mini printer rolls.

Divisions may draft their estimates and initiate procurement of above mentioned equipment under "Revenue". The list of 86 Phase-III (PPMS) locations and the number of terminals sanctioned at each of these locations is enclosed as **Annexure-A**. The number of equipment should be commensurate with the number of terminals sanctioned and actual requirement at the stations.


Divisions are advised to ensure identification/site preparedness at the parcel offices and procurement of all items under "Revenue" is completed by August 2021, as advised by CAO/PIS vide letter dated 22.02.2021.

Implementation of Parcel Management System on South Central Railway is one of the actionable points noted during CRB's PNM (VC) on 20.02.2021.

In view of the above, Divisions are advised to take necessary action

- (i) For replacement of PMS equipment at the 18 Phase-I stations in LSWP 2021-22 under PH 1700, for which consumable items are supplied by Head Quarters office.
- (ii) to ensure site preparedness for implementation of PMS by CRIS at 04 Phase-II stations, for which networking, hardware and consumable items shall be supplied by CRIS.
- (iii) for procurement of PMS equipment and consumables under "Revenue" at 86 Phase-III locations .

Reference This office letter of even number dated 4.9.2020 (copy enclosed)

Kindly refer to this office letter mentioned above. Railway Board had conveyed its sanction for 523 stations. (206 stations identified under earlier under PPMS and 317 newly identified station) now to be covered under the work of "Proliferation of Parcel Management System on all stations of Indian Railway upto B category (PPMS)".

As conveyed by Board in their letter dated 26.8.2020 (ED (C&IS) number 2020/ C&IS/ Project/ PMS progress/ 4 dated 26.8.2020), it was decided that PPMS implementation shall **not** be done centrally by CRIS. The breakup of the items and the agency to initiate procurement is reiterated as under:

1. By CRIS under "Capital (DF-3)" estimates

- Thin Client along with 20% spare
- UPS along with 20% spare
- Networking equipment at stations at the identified 523 stations.

CRIS has already been asked to revise the Detailed Estimate sanctioned earlier.

2. By Zonal Railways under "Revenue" estimates.

- Electronic Weighing Scale – weighing of parcel packages
- PW bill printers (24 pin 80 column) – generation of PWB and LT
- Barcode printers – printing of barcode labels to be pasted on packages
- Report generation printers (9 pin 136 column) – generation of accounting report
- Mini Printers – generation of loading summary SLR/ VPU wise
- Hand Held Terminals – for reading of barcode on loaded and unloaded packages &
- Consumable like, Parcel Way Bills stationary, Barcode Sticker, Barcode Ribbon and mini printer ribbons.

As already advised, Zonal Railway may like to draft their estimates and initiate procurement under "Revenue":

The specifications and LAR of the under mentioned equipment shall preferably be guided as per latest procurement by CRIS under the project of Computerization of Parcel Management System over major station of IR – Phase – II".

The number of equipment should be commensurate with the number of terminals sanctioned and actual requirement at the stations.

2 This office letter of even number dated 17.2.20211. Board vide its letter dated 15.2.2021 (refer SN 1 above), has conveyed the timelines for
implementation of PMS to CRIS, which is reproduced verbatim as under:

“CRIS will ensure implementation of PMS phase II covering 143 stations and Phase III covering 523 stations within 6 months. CRIS shall finalize and communicate the timelines for implementation of the two phases within next fortnight.”

2. Accordingly, CRIS vide their letter dated 19.2.2021 (refer SN 2 above), has communicated/
committed the time lines for implementation of the Phase III of PMS (PPMS) at 523 locations by
the end of September 2021.3. The list 523 stations, (206 stations identified under earlier under PPMS and 317 newly identified
station) now to be covered under the work of PPMS is attached at **Annexure A**

4. Zonal Railway may like to ensure the following:


(a) Identification/ Preparation of site at parcel office.

(b) Provision of Cable pair, if required, for providing last mile connectivity from POP (point of
presence) of UTN (Unified Ticketing Network of UTS and PRS) at stations to the Parcel office.

*Authority: Railway Board letter number 2012/ C&IS/ PMS/ Progress dated 6.9.2013 jointly
issued by Telecom and C&IS dtc. (copy attached as Annexure B)*

NB: CRIS shall provide the data communication equipment for network connectivity from
POP of UTN to parcel office.(c) Zonal Railway must ensure procurement of all items under “Revenue” as mentioned in this
office letter dated 17.2.2020 are **completed by August 2021** (copy enclosed as Annexure C).5. The specification of *Electronic Weighing Scale (EWM/ EWS), PW bill printers (DMP) (24 pin 80
column), Barcode printers, Report generation (DMP) printers (9 pin 136 column), Hand Held Mini
Printers, Hand Held Terminals/ Scanner & Consumable viz. Barcode Sticker/ Labels, Barcode Ribbon
Labels and mini printer ribbons, as conveyed by CRIS is attached as Annexure D.*
