As all trains from VSKP towards BZA direction are traditionally manned by SCR Ticket Checking Staff, it was decided to man Vande Bharat express train No.20833/20834 by SCR Ticket Checking Staff between VSKP-SC-VSKP and the same was communicated vide control message vide reference-3. The request from your Railway vide letter under reference-1 was examined and in order to avoid pilot working of ticket checking staff from both Railways, it is proposed that, SCR Staff will man the train between SC-BZA-SC and ECoR staff will man between VSKP-BZA-VSKP. This arrangement will meet the requirement of both the Railways.
