## 2.3 Vijayawada

- > To clear the demurrage charges of Rs. 1.13 Cr. Of Division at the earliest.
- ➤ Division considering the basic pay of the employee should clear the debit at the earliest instead of 24 months, which was initiated against the employee for loss of EFT Books for a period of 24 Months for the debit of Rs 1.91 Lakhs. The salary recovery at present is Rs. 8000 per month.
- ➤ The debit of Rs.1,00,000 rose against premium booking advance at AKPK to be cleared at the earliest.
- ➤ The credit proposals submitted for the debits raised at SLO, ASLS and TEL are to be obtained by co-coordinating with the traffic accounts and should be dropped within this financial year.
- ➤ The debit of Rs 20,944/- at Dwarapudi which was raised against deceased employee and division has addressed a letter to Sr.DPO for recovering of the same has to be fast tracked.
- ➤ The debit at Chirala for not receiving the acknowledgement of the vouchers sent to the vouchers section. The salary recovery which was proposed by the division has to be fast tracked.
- > The following court cases over the BZA division has to be followed up on fast track:
  - a) The case at Ongole and Tanguturu, regarding the freight loaded against the Standard Rake Indent pertains to 2004 has not been listed in the Telengana High Court since 2022.
  - b) The court case of M/s GNG exports regarding the punitive charges raised at SLO; BVM has been closed by the Andhra Pradesh high court stating that there is out of settlement by the Railway's. The division should take necessary steps to realize the outstanding and to reopen the case.

- ➤ The outstanding lying against Digi Payments over NED division are to be cleared by coordinating with the Traffic Accounts by submitting the required documents on priority basis.
- It was informed by the division that the attachment suit which was initiated by the division regarding the debit of Rs. 78 lakhs has a time limit of 3 years from the date of raise of debit. But it is advised that the Legal opinion has to be taken regarding the time period of the attachment of properties of the employee.
- ➤ The Court case lying against Shri. G karunakar for misappropriation of Railway cash did not come to hearing till date. Necessary steps maybe taken for listing of the case on the bench.

- > All vouchers are to be sent daily to the Voucher office and obtain the acknowledgements without any delay.
- > If there is delay in receiving the acknowledgements it should be brought to the notice of the traffic accounts.
- ➤ All the Goods and Coaching balance sheets are to be finalized on 01-04-2024 without fail.
