All Plan Head coordinators are advised to propose new works in PWP 2022-2023 only if it can be taken up immediately duly considering the objectives to be achieved.

All Plan Head coordinators are requested to take GM's approval for the new proposals of individual works and submit a copy to Head Quarters on or before 10.12.2021 for forwarding the same to the Railway Board for inclusion in Works Programme 2022-23.

Sub: Processing for Works Programme 2022-23 on Indian Railways.

- 1. The annual exercise of Works Programme for the financial year 2022-23 is required to be undertaken by the Railways.
- 2. Railways focus should be on completion of already sanctioned works so as to complete them in a time bound manner and timely utilize the investment made. A new work should be proposed only when the railway is of the view that the proposed work has to be taken up immediately duly considering the objectives to be achieved. Hence, a Zero Based review be conducted including, inter alia, already sanctioned works.
- 3. In this context, Board desires that in order to reduce throw forward liabilities, a review should be done for such sanctioned works which have not commenced in spite of lapse of considerable time. Such works might have lost relevance in the present scenario and need to be dropped.
- 4. From the year 2018-19, the concept of Umbrella works has been introduced. The detailed procedure to deal with these works has already been issued vide Board's letter No. 2017/CE-I/WP/2018-19/1 Pt. dt. 19.07.18 & 30.09.2019. Further, to that, the following may be noted for Works Programme 2022-23:
 - a. The new works shall be sanctioned only as umbrella work.
 - b. The name and cost of each umbrella work shall be proposed by the nodal directorate for finalization of the same jointly by Executive Directors of nodal directorate in consultation with associated directorate' and associate finance directorate. While arriving at the name and cost of proposed umbrella works, individual works proposed by railway shall also be considered by the nodal directorate.
 - c. Under Plan Head 16, 17, 18, 29, 30, 32, 33, 36, 42, 51, 53, 64 & 65 individual works in any umbrella work can be sanctioned in subsequent financial years till the cost limit of umbrella work is exhausted subject to the following:
 - i) Any unutilized provision of the Umbrella work of 2018-19 stands lapsed as per Board's letter No.2020/F(X)II/PW/3/Pt dated 04.05.2021.
 - ii) The unutilized provisions of the Umbrella Works of 2019-20, 2020-21 & 2021-22 shall be considered as lapsed on the following dates:-

| Umbrella Works | Date |
|----------------|------------|
| 2019-20 | 31.03.2022 |
| 2020-21 | 31.03.2022 |
| 2021-22 | 31.03.2023 |

- iii) Similarly, the unutilized provision of the future Umbrella works of 2022-23 onwards can be utilized for 2 years only.
- 5. While at the stage of proposing the Umbrella Works 2022-23, Zonal/PU finance concurrence is not necessary, a copy of the proposed works should inevitably be endorsed to associate finance for further necessary action.
- Accordingly, Railways/PUs should submit Vol-II containing new proposals of individual works to Board's office latest by 15th December, 2021 for Works Programme 2022-23.
- 7. The Vol.-I & Vol.-III for on-going works and other volumes of Works Programme may be submitted on IRPSM latest by 20th December, 2021.
