With reference to the above subject matter, instances have come to the notice of the Office where booking staff have accepted treasury remittance notes (challans) without bank stamp and signature from authorized agent of SBI (i.e., CMS info systems/secunderabad) for cash pick activity.

In this regard, it is advised that at all stations, staff need to be very alert and pay proper attention while receiving the challans from CMS agents after deposit of cash into nominated bank on the following day and verify for bank stamp, signature and other credentials.

In this connection an immediate exercise may be conducted to reconcile station earnings with remittances in bank from the date of introduction of cash pickep. A report in this regard may be sent to this Office immediately without fail.

Instances have to come to the notice of this office where booking staff have accepted Treasury Remittance Notes (Challans) without bank stamp & signature from authorized agent of SBI (i.e M/s CMS Info System/Secunderabad) for cash pick up activity.

Staff of CMS Info System which is authorized agent of SBI for cash pickup activity after collecting station earnings has returned bank challan to station staff without bank stamp and signature. CMS staff has failed to remit the station earnings into bank and misused railway cash for personal reasons. Station staff has not exercised proper care while receiving the challans. This has resulted in non-remittance of earnings on multiple occasions and non-detection of irregularities for some period.

In this regard, it is advised that at all stations, staff need to be very alert and pay proper attention while receiving the challans from CMS agents after deposit of cash into nominated bank on the following day and verify for bank stamp, signature and other credentials.

Further, divisions are advised to issue necessary instructions to field staff to ensure reconciliation efforts with SBI on periodical basis so as to arrest such instances and to ensure effective door step banking activity. An immediate exercise may be conducted to reconcile station earnings with remittances in bank from the date of introduction of cash pickup activity. A report in this regard may be sent to this office within a 23.08.23 without fail.
