Sub: Outstanding Security Deposits from the financial year 2012-13 to 2017-18.

A review of Suspense Ledger – Security Deposit Works (008445.53) was made after completion of July, 2021 accounts and it is noticed that more than 617 items amounting to Rs.4,77,14,751/- are outstanding since the year 2012-13 to 2017-18.

In this connection, it is to bring to your notice that in terms of Accounts Code Para 321, "Unpaid items other than unpaid wages of Railway staff amounting to more than Rs.100/- each should be allowed to remain in the Register of Deposits of the Railway for a period of three years, or until it is practically certain that no further claims for payment will be made. The sum may then with the personal approval of the Financial Adviser & Chief Accounts Officer be credited to the detailed head "Miscellaneous receipts" or "Traffic Accounts" according as they relate to works or Revenue transactions."

Further, Head quarters is insisting on early clearance of the outstanding items above three years old. Hence, a fresh list of outstanding items for more than three years old is enclosed for your ready reference and necessary action.

In view of the above it is advised to review the present status of the Works/Agreements and arrange to refund the security deposits to the contractors in respect of the works completed at the earliest. For the Security Deposit amounts which cannot be refunded and where there is no response from the contractors, such items may be transferred to "Sundry Earnings" with the approval of PFA/SC. A "No Objection Certificate" may be issued for transfer of items to Sundry Earnings by 24.09.2021.

The matter may please be treated as Most Urgent.
