The supervisory official under whom the above Pro. Commercial cum Ticket Clerks have undergoing practical training in the duties of CC/TCs may be relieved and directed to report to above mentioned stations duly issuing EDP for their journey to the place of posting. The supervisory officials concerned should relieve the Pro.CC/TCs to the above mentioned stations where they were posted with their photo identification letter and specimen signature duly attesting them.

They should vacate the Railway quarters if any under their occupation before carryout the transfer. The employees at S.No. 4, 5, 6, 8, 10, 11, 12, 13, 15, 16, 17, 18, 19, 20 are eligible for transfer benefits. They will be given independent charge in the duties of Commercial cum Ticket Clerk at the place of posting indicated above and the date of relief/joining should be advised to all concerned.

The above employees can exercise option for fixation of pay from 01.07.2020 i.e. from the date of accrual of increment in lower grade under FR 22 1(a)(1) and such option should be submitted to this office within one month from the issue of this office order.
