The date of assuming higher grade responsibilities by the above employees should be advised to all concerned. They will be on probation for a period of 12 months and their continuance in the higher grade will be subject to their successful completion of probation.

They should vacate the Railway Quarters if any under their occupation and handed over Railway property if any under their possession to the concerned supervisors before they carry out the transfer orders. They should be relieved immediately and the date of their relief at old station and date of joining at new stations should be advised to all concerned. They are eligible for transfer benefits on transfer account.
