Sub:- Re-engagement of retired Staff in Commercial Department BZA Div.
on daily remuneration basis.

Ref:- This office notification NO.SCR/BZA/P/Ruling/O/947 dt.09.09.19

In response to this office notification cited, retired employees who have applied and found suitable for re-engagement to work in Commercial Department of BZA Div. by the screening Committee as listed in Annexure "A" have been found fit in B-Two medical classification as mentioned against each.

Now, they are re-engaged to work Ticket Examiner (From S.No 1 to 17), ECRCs (From 18 to 21) listed in Annexure "A", in Commercial Department of BZA Division, subject to the terms and conditions mentioned below and posted in the stations mentioned against each.

1. The maximum upper age limit for re-engagement is below 65 years and no re-engaged employee should continue beyond 65 years of age.
2. The scheme of re-engagement is valid up to 01.12.2019. Hence the retired employees should be stopped from work 01.12.2019 or on the date of completion of 65 years of age whichever is earlier i.e. as shown in the annexure against each retired employee.
3. Operation of Scheme will be subject to discharge of engaged staff immediately on joining of selected candidates from RRB etc.
4. The administration reserves the right to terminate the re-engagement in case of unsatisfactory performance without any notice and the re-engaged person will have no prescriptive right for continuance.
5. Monthly remuneration of a retired employee to be determined by reducing pension from his last pay drawn. (Basic Pay+D.A) i.e. Monthly remuneration plus full pension should not exceed last pay drawn.
6. The muster particulars should be sent to this office by first day of the next month regularly without any delay for drawal of remuneration.
7. TA/DA as applicable and they are eligible for 08 days leave (on Prorate Basis) in a calendar year. *as per extant rules.*
8. All terms and conditions are applicable as per the notification dated 09.09.2019.
