Basing on the requests received from the Divisions 97 ATVMs wereprocured in October, 2022. Supply, installation and commissioning of these ATVMs was completed by 14/03/2023 as per the list annexed to the letter cited at reference (i) above.

Recently as part of the MMTS phase - II project, MMTS services were extended uptoUR from FM over STPD-UR section and new services were introduced on SC-MED section. To augment the ticketing infrastructure at the new MMTS stations and other non-suburban stations, DRM/HYB has requested for 63 additional ATVMs.

Keeping in view the time involved in indenting, finalisation, supply, installation and commissioning of new ATVMs, as an interim measure, it is proposed to relocate the released ATVMs that are functional to HYB Division. Details of the ATVMs proposed for relocation is enclosed.
