Apropos above, Railway Board vide letter under reference has examined the matter of providing resting facilities to AC escorting staff at out stations and following guidelines issued with approval of Board (MTRS). Following instructions issued by Railway Board may please be followed in toto and take care while framing any new estimates of running room/TTEs rest room.

1. Provision for resting facilities for AC escorting staff should be kept by zonal Railways in future construction works taken up by them for TTEs rest room/running room etc.,
2. ICF SG AC coaches available with Railways can also be utilized for resting of escorting ACCI & ACCAs at secondary terminals. These coaches should be stabled with proper charging facilities and basic amenities i.e, like water, toilets/bathrooms etc. for this purpose.

Divisions may please also examine the occupancy in existing running rooms/TTE rest room and may start allotting un utilized accommodation to escorting AC staff with immediate effect.

The matter regarding providing resting facilities to AC escorting staff at outstations has been deliberated and following guidelines are issued:-

- i. Provision for resting facilities for AC escorting staff should be kept by Zonal Railways in future construction works taken up by them for TTEs rest room/running room etc.
- ii. ICF SGAC coaches available with Railways can also be utilized for resting of escorting ACCI & ACCA at secondary terminals. These coaches should be stabled with proper charging facilities & basic amenities i.e. water, toilets/bathrooms etc. for this purpose.
- iii. WR, SR, NR & ER should start using ICF SGAC coaches' immediately on pilot basis and provide feedback to Board.
