**Sub:-**Restriction of parcel traffic over Delhi area in connection with **G-20 Summit**.

Keeping in view the security arrangement during **G-20 Summit**, restriction is hereby imposed on all types of parcels transactions (including leased) in Delhi area i.e. (NDLS, DLI, HNKM, ANVT & DEE stations) on **8<sup>th</sup>, 9<sup>th</sup> & 10<sup>th</sup> September 2023**. Parcel godowns and platforms shall remain free of parcel packages/packings. In the wake of **G-20 Summit**, restriction is imposed on both inward and outward traffic including leased SLR, AGC, VPs & PCETs at all the aforesaid stations.

The personal luggage may be allowed in the passenger coach only and booking of registered newspapers and magazines shall be permitted after observing all commercial formalities.

This restriction is applicable on leased SLR, AGC, VPs & PCETs of the trains originating/terminating from Delhi area stations i.e. (NDLS, DLI, HNKM, ANVT & DEE) and also applicable for passing trains originating from other divisions/zones, and having stoppages in Delhi area for loading/unloading.
