- 2) **One person** will be eligible to participate in **only one** of the **competitions** out of the three above.
- 3) The members of the Evaluation Committee and their Family members are not eligible to participate in the competitions)

Mode of Participation:-

- 1) In view of the Covid-19 pandemic, the participants are allowed to write the essay and make poster painting from their residence/ workplace.
- 2) Essays both Hindi and English would be of maximum 1000 words and must be legibly handwritten by the participant. **Typed entries will be disqualified.**
- 3) For poster painting the size of paper recommended is A1/A2/A3/A4 as per the availability. **Competitors must also give a suitable caption to their painting.**

4) All participants shall submit the scanned copies (preferably high resolution copies) of their entries by **16.00 hrs on 15.10.2020** to **vaw2020hyb@gmail.com**. Entries received after **16.00 hrs of 15.10.2020** shall not be considered.



General guidelines for conducting Hindi Essay Writing, English Essay Writing and Poster Painting Competitions

1. Hindi Essay Writing, English Essay Writing and Poster Painting competitions will be on the theme "सतर्क भारत, समृद्ध भारत – Satark Bharat, Samriddh Bharat (Vigilant India, Prosperous India)"
2. The activities relating to these Competitions e.g., conduct of Competitions, evaluation of the entries, selection of the prize winners, etc., must be carried out between 12th and 16th Oct, 2020.
3. All the employees (officers & staff) & their family members (as per Railway Pass Rules) working in your division would be eligible to participate in these Competitions. The only restriction is that one person can participate in only any one of the Competitions out of above three. (Note: The members of the Evaluation Committee and their family members will not be eligible to participate in the Competitions).
4. Physical mode of conducting these events is to be completely avoided, in order to prevent spread of the Covid-19 pandemic. Participants would be allowed to write the essay and make poster painting from their residence/workplace.
5. Essays both Hindi and English would be of **maximum 1000 words** and must be legibly **handwritten by the participant**. Typed entries may be disqualified.
6. For poster painting, the size of the paper recommended is A1/A2/A3/A4 as per the availability. Competitors must also give a suitable caption to their painting.
7. All participants may be asked to submit the scanned copies (preferably high resolution copies) of their work through online (e.g., email, shared folder etc.) to your nominated Evaluation Committee.

It is advised to strictly adhere to extant Covid-19 prevention guidelines at all locations and events issued from time to time by the competent authority.
