- 1. This office had issued instructions from time to time regarding precautions to be taken for prevention of fire incidences in Luggage Vans (SLRs)/Parcel Vans (VPs) of Passenger carrying trains. It was also advised to launch a campaign including arranging Safety Seminars with parcel leaseholders, handling agents and parcel staff to avoid fire accidents and loss to Railway property.
- 2. Instructions are issued from time to time for conducting of drives for prevention of fire and other untoward incidents.

3. In this regard, checks should be conducted as per the below given schedule by Headquarters and Divisional Officers, Commercial Inspectors and Supervisors of stations.
