#### Sub: Launching special ticket checking drives.

At present regular and surprise checks are conducted by Zonal Railways against passengers travelling without ticket/with improper ticket and various checks like ambush, cross country and fortress checks are conducted, keeping in view the local conditions and also after checking availability of security personnel.

1.1 With a view to prevent unauthorized travelling in trains and to realize the full potential of available ticket checking staff, it is desired that Zonal Railways should launch regular special ticket checking drives and action may be taken against passengers found travelling without valid travel authority/ ticket as per the provisions of the Railways Act, 1989. Such checks should be intensified during peak rush periods like festivals, holidays etc.

# Sub: Ticket Checking Drive in Special Trains run during COVID period.

During the COVID-19 pandemic, regular train services have been suspended till further orders and only limited special trains are being run. In pursuance of the protocol issued for Social Distancing and bare minimum attendance of staff, a limited number of Ticket Checking Staff have been deputed in trains and at stations. Since the unlock started, the movement of passengers has also started. During the checks conducted at certain locations, some irregularities have been brought to the notice.

1.1 It is, therefore, desired that the following action may be taken by the Railways duly following the protocol of social distancing :

(i). Adequate manning of the trains should be ensured so as to reduce the scope of irregularities being committed by unscrupulous elements.

(ii). 100% manning of the entry and exit gates may be ensured.

(iii). On those sectors where probability of misuse is more, checks may be conducted in the trains on periodical basis under the supervision of at least one gazetted officer.

2. Necessary instructions may be issued to all concerned accordingly.
