Railway Board vide letter referred above has advised to conduct special drive to prevent ticketless/unauthorized travelling in the upcoming festival/rush period as well as to facilitate ease in getting tickets (copy enclosed).

In this connection, Sr DCMs' are advised to draw an action plan and nominate an officer to monitor the drive for the period 20.10.23 to 27.11.23, wherein special focus should be on misuse of Emergency quota, Concession Quota such as senior citizen, cancer patient etc;. While conducting checks on EQ in trains, the enclosed Performa should be filled and kept as record.

Further, proper functioning of booking counters/ATVMs may be ensured to facilitate ease in ticket booking to passengers. Regular announcements should be made at stations for spreading awareness regarding travelling with valid ticket. The feedback on the drive conducted and the outcome may be submitted to this office by 30.11.23 positively.

Sub: Launching special ticket checking drive.

At present regular and surprise checks are conducted by Zonal Railways against passengers travelling without ticket/with improper tickets.

- 2. With a view to prevent ticketless/unauthorized travelling in the upcoming festival/rush period and to facilitate passengers in getting tickets, it is desired that Zonal Railways should take following action:
  - (i) A special ticket checking drive may be launched for the period 20.10.2023 to 27.11.2023. Suitable action may be taken against passengers found travelling without valid travel authority/ ticket as per the provisions of the Railways Act, 1989
  - (ii) Special emphasis may be given during this period on checking the accommodation released out of Emergency Quota and reserved accommodation obtained against specific quotas like senior citizen, cancer patient, etc., so as to keep a check on its misuse. The ticket checking staff may be instructed to ascertain the genuineness of the passengers by checking valid prescribed proof of identity.
  - (iii) Zonal Railways should nominate senior level officers to monitor these drives at divisional as well as zonal level. Feedback of these drives may be sent to this office by 04.12.2023 positively.
  - (iv) Ease in ticket booking may be facilitated by ensuring proper functioning of counters, opening of additional counters as per local requirement, operationalisation of all available ATVMs.
  - (v) Passengers intending to book tickets through ATVMs should not be prevented by facilitators.
  - (vi) Public address system should be used for spreading awareness regarding travelling with valid authority/ticket and booking tickets through authorized agents & UTSonMobile app/IRCTC website.
  - 3. Necessary instructions may be issued to all concerned accordingly.
