**Sub: Terminal Access Charge for container traffic at Container Rail Terminal**  
**Ref: (i) Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0**  
**(ii) Corrigendum No.17 to Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0**

In terms of Board's circular under reference (ii), the rate of Terminal Access Charge is Rs.1,60,000/- per rake per terminal. This rate is applicable for all types of Container Rail Terminals (CRTs) either Group-I or II or III.

The matter has been reviewed and Competent Authority has decided to grant incentive in Terminal Access Charge for handling of container traffic at Group-III CRT by charging it @50% of the prevailing rate of Terminal Access Charge, as given below-

Type of Container Rail Terminal (CRT)	Rate of Terminal Access Charge(TAC) (per rake per terminal)
Group-I CRT	Base Rate
Group-II CRT	(which at present is Rs.1,60,000/- per rake per terminal)
Group-III CRT	50% of the base rate

Zonal Railway must ensure timely review of classification of CRTs as per Para 3.3.3 of Chapter-I of Rates Master Circular under reference (i) and levy Terminal Access Charge accordingly.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.
