(b) to (e): During the National Ticket Checking Meet organized by IRTCSO (Indian Railway Ticket Checking Staff Organization) held on 05.09.2018 at Talkatora Stadium, New Delhi, the demand for considering Ticket Checking staff as Running staff was raised. This demand has also been raised by around 100 Hon'ble Members of Parliament. A committee has been constituted to examine the demand for consideration of Ticket Checking staff as Running staff. Further, instructions were issued to all Zonal Railways for provision of facilities in TTE rest house at par with that of running rooms of guards/loco pilots.

- (d) whether vigilance department of the Railways checks goods trains as well; and
- (e) if so, the number and details of the cases related to low fare that came to light during the last three years and the current year?

(a) and (b): All reserved coaches of trains are required to be manned by Travelling Ticket Examiners in accordance with the prescribed norms. The duties of the Travelling Ticket Examiners include checking of tickets of all the passengers in the coach/coaches assigned to them. Failure on the part of the Travelling Ticket Examiners to check the tickets of passengers renders them liable for action under the Discipline and Appeal Rules.

(c): The Zone-wise details of vacancies in ticket checking cadre are as under:

(d) and (e): Yes, Sir. With a view to detect irregularities in freight realization, regular preventive checks are conducted by vigilance department and penal undercharges on account of misdeclared commodities/overloading by Goods Trains are realized wherever such irregularities are detected. Since the year 2017 about 1200 checks have been conducted and an amount of approximately ₹ 53 crore have been realized in this regard.
