The contracts for vending of miscellaneous items (other than food items) in trains between Gudur-Vijayawada & Vijayawada-Anakapalle stations has been awarded to Smt Likhita Nathani for a period of 3 years from 02-03-2023 to 01-03-2026, vide LoA's referred above.

The contract involves selling of approved miscellaneous items (copy enclosed) in trains between Gudur-Vijayawada section and Vijayawada-Anakapalle section (including branch line), this office will issue ID cards and travel authority to individual vendor. <u>A vendor shall be treated as authorised only when he is in possession of both ID card and travelling authority</u>. As the contract is to be operated in trains running over the division on board ticket checking staff are instructed to maintain attentiveness towards the vendors selling miscellaneous items on trains and check whether vendors are following conditions specified in Annexure.

Any person found doing vending of miscellaneous items (other than food items) within the ambit of aforesaid contract without ID card and travelling authority together shall be treated as travelling without ticket and dealt accordingly in addition the matter shall be reported to this office for necessary penal action. Further, if the vendor is found selling unapproved items the same shall be reported to this office immediately for initiating necessary penal action.

#### <u>Annexure</u>

#### **SALE OF ITEMS**

- a) The Licensee shall not sell the items other than those approved by the Railway (copy enclosed). Sale of unauthorized items/items not specified in the approved list if detected, the Railway or its authorized representative/official may seize such items and the seized items shall be disposed off as per policy of the Railway in addition to any penalty to be imposed for such contravention.
- b) Bill book shall be available with every vendor during vending in trains, vendor should provide bill for every transaction in the train. The vendor shall also make arrangements for collection of charges through digital means of payment. Proper rate list shall be displayed by the vendor to the passenger.
- c) Miscellaneousitems permitted for sale should have MRP, date of manufacture, expiry date and other specifications as given on the packaging.
- d) The license is for sale of miscellaneous items in trains only; vendors are not permitted to sell items in station/ platforms/Circulating area.
- e) Licensee should not store any items in station platform or in train. He will have their own storage facility outside the Railway area. If items are detected to be stored in train/ station premises, the Railway or its authorized representative/official may seize such items and the seized items shall be disposed off as per policy of the Railway in addition to any penalty to be imposed for such contravention.

#### **BAN ON SALE OF PRODUCTS**

The Licensee shall not sell/distribute tobacco products, wine, beer or any other alcoholic drinkor any other item prohibited by law on the Train.

#### LIST OF ITEMS NOT PERMITTED FOR SALE

Food Items, Packaged Drinking Water, Aerated Drinks, Liquors, Inflammable Items, Paan Masala, Vulgar Literature, Obscene, any time Intoxicantitems. Arms, Contraband items.

#### **DEPLOYMENT OF ON-BOARD STAFF**

The Licensee will deploy 4 (four) vendors for one train. In addition, the Licensee shall have onesupervisor. Approved vendorsare allowed to sell items between 06.00 hrs to 21.00 hrs only.Total 25 venders will beworking in between the section with Maximum 5 (4+1) persons in one train.

#### **STAFF UNIFORM, IDENTITY CARDS**

- (a) The Licensee shall provide distinctive uniforms for vending staff.
- (b) Identity cards will be issued by Railways.

#### **BONAFIDE TRAVEL BY THE LICENSEE'S STAFF**

- (a) Travelling authority will be issued by railways for the staff of the Licensee who are permitted to sell miscellaneous items in trains.
- (b) The staff of the licensee will carry valid travel authority and medical fitness certificate to be issued by the Railway on the request of the Licensee. The Licensee shall ensure that the identification card and traveling authorities of the staff should be duly attested by the Railway.
- (c) Vendors found without valid ID card and travel authority will be treated as unauthorized hawking and will be taken up as per procedure, along with confiscating all the vending items in their possession.

**2.** Hence pay Rs.10,84,685/- towards 1<sup>st</sup> half yearly license fee and Rs.12,02,069/- towards Security deposit. In addition to the above, you have to submit Invoice towards GST @18% of six months of first year's license fee i.e., Rs.1,95,243.3/-.

**3.** Please arrange to pay the amounts as described above within Twenty (20) days from the date of acknowledgement of LoA. In case of delay in payment of Licence fee/security deposit beyond this 20 days period, penal interest will be charged @ 18% per annum on license fee for the delay period i.e. for the time period beyond the due date and 40 days time period from due date. The due date will be 20 days from the date of acknowledgement of LOA. **4.** In addition to the above, the licensee should pay the Income Tax, utility charges and other applicable taxes to the Statutory Authorities and submit the copies of receipts to Railways.

**5.** You have to submit the duplicate copy of the LoA to Railways after acknowledging the same. The actual date of submission of acknowledged copy of LoA in the office of Sr.DCM will be the <u>date of acknowledgement of LoA</u>. However, this date of submission cannot be beyond Seven (7 days) from the date of receipt of RPAD. If you fail to submit the acknowledgement copy of LoA within the stipulated time period, the LoA will be cancelled automatically and the contract will be deemed as terminated. The Earnest Money Deposit amount will be forfeited and appropriated by Railways. Further, you will be disqualified from participating in any tenders on South Central Railway for a period of 3 years. 6. Security Deposit should be submitted by way of irrevocable Bank Guarantee/Fixed Deposit Receipt issued by a Nationalized Bank/Scheduled Bank drawn in the name of Sr. Divisional Finance Manager, Vijayawada Division, South Central Railway. The validity period of Bank Guarantee should be Six months more than the total contract period i.e., should be forty two (42) months. 7. The license fee of the subsequent six months periods should be paid 15 days before the commencement of next six months period for which license fee is due. Any delay in payment of license fee beyond 15 days shall attract interest @ 18% per annum calculated for the number of days of delay. In the case you fails to pay the license fee within 90 (Ninety) days after the due date (Due date is 15 days before the commencement of subsequent six months period. So, 90 days=15 days before+75 days after the commencement of the six months period), the license will be terminated by treating it as breach of contract without issuing any notice of termination and with all attendant liabilities.

**8.** Payment of license fee in time is entirely the responsibility of the Licensee. Railway will not give any reminder or advance notice or intimation prior to the due date of payment.

**9.** The date of commencement of contract will be from 60 days after acknowledgement of the LoA by the licensee or actual date of first display of the Advertisement whichever is earlier.

- 10. All miscellaneous items had to be supplied to passengers as permitted by the Railway. Licensee shall also ensure waste is disposed off in environmental friendly manner as per statutory regulations and guidelines and instructions issued by Railways from time to time. The licensee shall further be responsible to make adequate arrangements manpower, at its own cost.
- 11. The licensee shall be responsible for ensuring the quality of products sold. The licensee shall depute trained staff who will be required to manage selling items to the passengers travelling on-board, maximum of 5 vendors per train. The licensee shall ensure that the staff should maintain good conduct, etiquette, personal hygiene, politeness and courtesy, issue bills to

**I/90101/2022** passengers etc. Further, the licensee shall ensue that the staff should be well groomed, wear proper uniforms, (as approved by Railway administration), badges displaying their names, carry photo identity cards, display at all times. All liabilities like Salaries, wages and other statutory obligations in respect of the persons engaged by the Licensee shall be borne by them. The Licensee shall take necessary steps to cover its employees under the said enactments and shall submit proof of such compliance at any date upon such request, as may be made by Railway. The staff engaged by the licensee, shall at no stage have any claim for employment in the Railways. This fact should be incorporated in their appointment letter, if any, issued by the licensee.

#### 12. SALE OF ITEMS

a) The Licensee shall not sell the items other than those approved by the Railway (given in <u>Annexure-IV</u>), the licensee will obtain approval from Sr.DCM for all items that he is willing to sell in the train, the items list along with their company name and MRP should be submitted for approval. Sale of unauthorized items/items not specified in the approved list if detected, the Railway or its authorized representative/official may seize such items and the seized items shall be disposed off as per policy of the Railway in addition to any penalty to be imposed for such contravention. However, the licensee may apply in advance for including additional items that are not specified in Annexure-IV of the tender document.Sr.DCM may permit inclusion of such items on payment of additional license fee.

#### 14. DEPLOYMENT OF ON-BOARD STAFF

The Licensee will deploy 4 (four) vendors for one train. In addition, the Licensee shall have one supervisor. The vending staff must be courteous and polite to every passenger at all times. Licensee is allowed to sell items between 06.00 hrs to 21.00 hrs only.Total 25 venders will be working in between the section with Maximum 5 (4+1) persons in one train.

#### 15. STAFF UNIFORM, IDENTITY CARDS

- (a) The Licensee shall provide distinctive uniforms for vending staff. The Licensee shall seek approval of the pattern and style of uniforms to be adopted for the vending staff from the Railway. The Licensee shall ensure that the vending staff to be deployed on the Train must be well groomed.
- (b) Identity cards will be issued by Railways. Licensee should apply for identity cards for vendors, the following documents should be submitted when applying for identity cards
  - i. individual Aadhaar card
  - ii. Police verification certificate
  - iii. Medical fitness certificate from railway hospital.

#### 16. BONAFIDE TRAVEL BY THE LICENSEE'S STAFF

(a) Travelling authority will be issued by railways for the staff of the Licensee who are permitted to sell miscellaneous items in trains.

- I/90101/2022 (b) The Licensee shall not permit anyone except the bonafide staff of the Licensee for whom identity cards are issued, to travel in the Train and ensure that the staff shall not carry in the Train any article of any description other than those required for the fulfillment of the obligations contained herein.
  - (c) The staff of the licensee will carry valid travel authority and medical fitness certificate to be issued by the Railway on the request of the Licensee. The Licensee shall ensure that the identification card and traveling authorities of the staff should be duly attested by the Railway.

#### 17. MISUSE/LOSS OF TRAVELLING AUTHORITY

- (a) The Licensee shall not allow Railway passes to be used for any work other than the Railway work viz., vending of miscellaneous items on the Train and agrees that any breach of this condition shall be deemed to the breach of this Agreement.
- (b) In the event of loss of travelling authority the Licensee shall immediately report such loss to the nearest Station Master and to the Railway administration.
- (c) It is clarified that the cost, penalties, etc. as may be prescribed by the Railway from time to time for misuse/loss of travelling authority by the Licensee and/or its staff shall be borne by the Licensee.

#### 18. ENQUIRY INTO THE ANTECEDENTS OF THE LICENSEE'S EMPLOYEES

The licensee shall not in any capacity employ any person of bad character or any person, whose antecedents have not been investigated / certified by the Police Authorities/MP/MLA/MLC/ Councilor/ Gram PanchayatSarpanch/1<sup>st</sup> Class Magistrate / Gazetted Officer and shall issue an appointment certificate (signed by the Licensee) which shall contain a photograph of the employed with his or her left/right hand thumb impression affixed thereon in Printer's ink which he will carry with him/her while on duty. The expenses for such verification are to be borne by the Licensee.

19. Inspection by Railway officials: The Railway shall have the right to inspect/ check the services provided by the Licensee for reviewing its standards, at any time and may authorized any person or agency for this purpose to access the performance of the licensee. In case of unsatisfactory performance or complaint of any nature, the Railway will be entitled to initiate the suitable action against the licensee including termination of this agreement as per the terms and conditions of this agreement. The Railway shall be entitled to take independent user's feedback to know the level of passenger satisfaction of the Licensee's service.

#### 20. <u>PENALTY</u>

Without prejudice to the other remedies which may be available under the license, the licensee/s shall be liable to pay at the sole discretion of the administration a penalty not less than a sum of Rs.2,000/- for any action contravention to any of the clauses under this agreement. The penalty so levied shall be paid by the licensee within a week from the date of demand for payment and failing which necessary action will be initiated against the licensee as deemed fit.

The fines/penalties shall be decided by ACM and above level officers of the division; however, Sr.DCM shall have overriding power to decide the fine over and above the quantum of penalties. In case of serious default or repeated failures, Sr.DCM may use his/her discretion for imposition any type of punitive fines/action which shall be binding on the licensee. The penalty (ies) that may be levied by the Railway on the Licensee in any of the instances

- (a) Forfeiture/appropriation of the Security Deposit in whole or part thereof, furnished by the Licensee; and /or
- (b) to annul the license and forthwith terminate the License Agreement; and/or
- (c) Debar the Licensee from participating in the future tenders of the Indian Railway for a period of three (3) years.
- **21.** The licensee shall make arrangements for collection of charges through mode of digital also by means of payment through POS/UPI payments. The Railway administration will not provide any infrastructure facility and it is the responsibility of the licensee to make necessary arrangements for operation of the digital instruments.

- **I/90101/20222.** During the Term if this Agreement, the Licensee will obtain and maintain at its own expense, unequal insurance with regards all its obligation under this agreement including insurance for workers compensation, life insurance, health insurance, accident 86 risk insurance, for employees including the stuff of the License. The Licensee hereby agrees and confirms that Railways shall be not be responsible in any manner whatsoever towards claims of the personnel, employees, directors, etc. of the Licensee.
  - **23.** License shall be abide instructions issued by Railway Board, Zone and Division time to time. Licensee shall ensure that all vendors in the train should follow cleanness as per guidelines and COVID protocol issued by state /Central government time to time.
  - 24. The Licensee/Licensees shall not sublet/transfer/assign the privilege of this license to any other person/s in any form/shape/for any consideration. The administration shall have the right to cancel the license if it is found to be sublet/transfer to any other person by giving show-cause notice.

#### 25. LAWS GOVERNING THE LICENSE:

The licensee shall be responsible to comply with the provisions enumerated in the various Laws of Land for the time being in force including the following laws:-

- (a) Minimum Wages Act, 1948
- (b) Payment of Wages Act, 1936
- (c) Contract Labour (Regulation and Abolition) Act, 1970
- (d) Workmen's Compensation Act, 1923
- (e) Child Labour (Prohibition and Regulation) Act

The laws of India shall govern this license for the time being in force including labour laws. This license shall be deemed to have made at the place from which the acceptance of the license has been issued.

The license/licensees jointly and each of them severally shall at all times keep the administration their office and servants harmless indemnified against and shall reimburse to the administration their officers and servants or any of them all claim demands, suits, losses, damages, costs, charges and expenses what so ever including any claim under Workmen's Compensation Act, 1923, and any amendments thereof which the administration their officers or servants may sustain or incur or become liable to pay by reason or in consequence what so ever whether owing to the neglect, carelessness or any other either of his/her/their servants/agents and other in her/his/their employee/s during the use by her/him/them of the license of the said area on by any part thereof.

The licensee shall employ only the persons who have completed 18 years of age and after due verification of the antecedents by the local police in respect of each person employed by her/him/them.

The licensee/ licensees shall not pay less than the minimum wage to the workers engaged by him/her/ them, and shall otherwise comply with the provisions of the payment under "Payment of Wages Act 1936" or any statutory modification or re-enactment thereof or rules framed there under.

- **26.** <u>UNTOWARD INCIDENCE</u>: The Railway administration shall not be liable to pay any compensation to the public for any negligence of the licensee resulting in injuries or death. The licensee shall be bound to pay any claims arising out of such incidence as per Railway rules and shall also abide the decision of the Railway Claims Tribunal under section 124/A of The Railways Act 1989 or any other decision given by court of Law on this matter. The Licensee shall be responsible for any damage caused to Railway property arising due to the acts of omission or commission of the staff by the Licensee.</u>
- 27. An agreement should be signed between Railways and Licensee within 10 days after the date of payment of Security Deposit and first six months licensee fee by the Licensee. Failure to sign the agreement within this stipulated period by the Licensee will be treated as breach of contract with all attendant liabilities. The acceptance of the tender shall constitute binding contract between you and the Railway Administration until the formal agreement is

**3.** Please arrange to pay the amounts as described above within Twenty (20) days from the date of acknowledgement of LoA. In case of delay in payment of Licence fee/security deposit beyond this 20 days period, penal interest will be charged @ 18% per annum on license fee for the delay period i.e. for the time period beyond the due date and 40 days time period from due date. The due date will be 20 days from the date of acknowledgement of LOA. Any delay in payment of first six months license fee beyond the stipulated period of Sixty (60) days will

6. **11.** The licensee shall be responsible for ensuring the quality of products sold. The licensee shall depute trained staff who will be required to manage selling items to the passengers travelling on-board, maximum of 5 vendors per train. The licensee shall ensure that the staff should

**I/90100/2022** maintain good conduct, etiquette, personal hygiene, politeness and courtesy, issue bills to passengers etc. Further, the licensee shall ensue that the staff should be well groomed, wear proper uniforms, (as approved by Railway administration), badges displaying their names, carry photo identity cards, display at all times.All liabilities like Salaries, wages and other statutory obligations in respect of the persons engaged by the Licensee shall be borne by them. The Licensee shall take necessary steps to cover its employees under the said enactments and shall submit proof of such compliance at any date upon such request, as may be made by Railway. The staff engaged by the licensee, shall at no stage have any claim for employment in the Railways. This fact should be incorporated in their appointment letter, if any, issued by the licensee.

#### 12. SALE OF ITEMS

a) The Licensee shall not sell the items other than those approved by the Railway (given in <u>Annexure-IV</u>), the licensee will obtain approval from Sr.DCM for all items that he is willing to sell in the train, the items list along with their company name and MRP should be submitted for approval. Sale of unauthorized items/items not specified in the approved list if detected, the Railway or its authorized representative/official may seize such items and the seized items shall be disposed off as per policy of the Railway in addition to any penalty to be imposed for such contravention. However, the licensee may apply in advance for including additional items that are not specified in Annexure-IV of the tender document. Sr.DCM may permit inclusion of such items on payment of additional license fee.

- b) Bill book shall be available with every vendor during vending in trains, vendor should provide bill for every transaction in the train. The vendor shall also make arrangements for collection of charges through digital means of payment. Proper rate list shall be displayed by the vendor to the passenger.
- c) Items permitted for sale should have MRP, date of manufacture, expiry date and other specifications as given on the packaging.
- d) The license is for sale of miscellaneous items in trains only; vendors are not permitted to sell items in station/ platforms/Circulating area.
- e) Licensee should not store any items in station platform or in train. He will have their own storage facility outside the Railway area.

#### 13. BAN ON SALE OF PRODUCTS

The Licensee shall not sell/distribute tobacco products, wine, beer or any other alcoholic drink or any other item prohibited by law on the Train.

**List of item not permitted for sale:** Food Item, Packaged Drinking Water, Aerated Drinks, Liquors, Inflammable Items, Paan Masala, Vulgar Literature, Obscene, any time Intoxicant items. Arms, Contraband items.

#### 14. DEPLOYMENT OF ON-BOARD STAFF

The Licensee will deploy 4 (four) vendors for one train. In addition, the Licensee shall have one supervisor. The vending staff must be courteous and polite to every passenger at all times. Licensee is allowed to sell items between 06.00 hrs to 21.00 hrs only. Total 25 venders will be working in between the section with Maximum 5 (4+1) persons in one train.

#### 15. STAFF UNIFORM, IDENTITY CARDS

- (a) The Licensee shall provide distinctive uniforms for vending staff. The Licensee shall seek approval of the pattern and style of uniforms to be adopted for the vending staff from the Railway. The Licensee shall ensure that the vending staff to be deployed on the Train must be well groomed.
- (b) Identity cards will be issued by Railways. Licensee should apply for identity cards for vendors, the following documents should be submitted when applying for identity cards
  - 1. individual Aadhaar card
  - 2. Police verification certificate
  - 3. Medical fitness certificate from railway hospital.

#### 16. BONAFIDE TRAVEL BY THE LICENSEE'S STAFF

- **I/90100/2022** (a) Travelling authority will be issued by railways for the staff of the Licensee who are permitted to sell miscellaneous items in trains.
  - (b) The Licensee shall not permit anyone except the bonafide staff of the Licensee for whom identity cards are issued, to travel in the Train and ensure that the staff shall not carry in the Train any article of any description other than those required for the fulfillment of the obligations contained herein.
  - (c) The staff of the licensee will carry valid travel authority and medical fitness certificate to be issued by the Railway on the request of the Licensee. The Licensee shall ensure that the identification card and traveling authorities of the staff should be duly attested by the Railway.

#### 17. MISUSE/LOSS OF TRAVELLING AUTHORITY

- (a) The Licensee shall not allow Railway passes to be used for any work other than the Railway work viz., vending of miscellaneous items on the Train and agrees that any breach of this condition shall be deemed to the breach of this Agreement.
- (b) In the event of loss of travelling authority the Licensee shall immediately report such loss to the nearest Station Master and to the Railway administration.
- (c) It is clarified that the cost, penalties, etc. as may be prescribed by the Railway from time to time for misuse/loss of travelling authority by the Licensee and/or its staff shall be borne by the Licensee.

#### 18. ENQUIRY INTO THE ANTECEDENTS OF THE LICENSEE'S EMPLOYEES

The licensee shall not in any capacity employ any person of bad character or any person, whose antecedents have not been investigated / certified by the Police Authorities/MP/MLA/MLC/ Councilor/ Gram Panchayat Sarpanch/1<sup>st</sup> Class Magistrate / Gazetted Officer and shall issue an appointment certificate (signed by the Licensee) which shall contain a photograph of the employed with his or her left/right hand thumb impression affixed thereon in Printer's ink which he will carry with him/her while on duty. The expenses for such verification are to be borne by the Licensee.

#### 19. Inspection by Railway officials:

The Railway shall have the right to inspect/ check the services provided by the Licensee for reviewing its standards, at any time and may authorized any person or agency for this purpose to access the performance of the licensee. In case of unsatisfactory performance or complaint of any nature, the Railway will be entitled to initiate the suitable action against the licensee including termination of this agreement as per the terms and conditions of this agreement. The Railway shall be entitled to take independent user's feedback to know the level of passenger satisfaction of the Licensee's service.

#### 20. <u>PENALTY</u>

Without prejudice to the other remedies which may be available under the license, the licensee/s shall be liable to pay at the sole discretion of the administration a penalty not less than a sum of Rs.2,000/- for any action contravention to any of the clauses under this agreement. The penalty so levied shall be paid by the licensee within a week from the date of demand for payment and failing which necessary action will be initiated against the licensee as deemed fit.

The fines/penalties shall be decided by ACM and above level officers of the division; however, Sr.DCM shall have overriding power to decide the fine over and above the quantum of penalties. In case of serious default or repeated failures, Sr.DCM may use his/her discretion for imposition any type of punitive fines/action which shall be binding on the licensee. The penalty (ies) that may be levied by the Railway on the Licensee in any of the instances.

- (a) Forfeiture/appropriation of the Security Deposit in whole or part thereof, furnished by the Licensee; and /or
- (b) to annul the license and forthwith terminate the License Agreement; and/or
- (c) Debar the Licensee from participating in the future tenders of the Indian Railway for a period of three (3) years.

- **I/90100/20221.** The licensee shall make arrangements for collection of charges through mode of digital also by means of payment through POS/UPI payments. The Railway administration will not provide any infrastructure facility and it is the responsibility of the licensee to make necessary arrangements for operation of the digital instruments.
  - 22. During the Term if this Agreement, the Licensee will obtain and maintain at its own expense, unequal insurance with regards all its obligation under this agreement including insurance for workers compensation, life insurance, health insurance, accident 86 risk insurance, for employees including the stuff of the License. The Licensee hereby agrees and confirms that Railways shall be not be responsible in any manner whatsoever towards claims of the personnel, employees, directors, etc. of the Licensee.
  - 23. License shall be abide instructions issued by Railway Board, Zone and Division time to time. Licensee shall ensure that all vendors in the train should follow cleanness as per guidelines and COVID protocol issued by state /Central government time to time.
  - 24. The Licensee/Licensees shall not sublet/transfer/assign the privilege of this license to any other person/s in any form/shape/for any consideration. The administration shall have the right to cancel the license if it is found to be sublet/transfer to any other person by giving show-cause notice.

#### 25. LAWS GOVERNING THE LICENSE:

The licensee shall be responsible to comply with the provisions enumerated in the various Laws of Land for the time being in force including the following laws:-

- (a) Minimum Wages Act, 1948
- (b) Payment of Wages Act, 1936
- (c) Contract Labour (Regulation and Abolition) Act, 1970
- (d) Workmen's Compensation Act, 1923
- (e) Child Labour (Prohibition and Regulation) Act

The laws of India shall govern this license for the time being in force including labour laws. This license shall be deemed to have made at the place from which the acceptance of the license has been issued.

The license/licensees jointly and each of them severally shall at all times keep the administration their office and servants harmless indemnified against and shall reimburse to the administration their officers and servants or any of them all claim demands, suits, losses, damages, costs, charges and expenses what so ever including any claim under Workmen's Compensation Act, 1923, and any amendments thereof which the administration their officers or servants may sustain or incur or become liable to pay by reason or in consequence what so ever whether owing to the neglect, carelessness or any other either of his/her/their servants/agents and other in her/his/their employee/s during the use by her/him/them of the license of the said area on by any part thereof.

The licensee shall employ only the persons who have completed 18 years of age and after due verification of the antecedents by the local police in respect of each person employed by her/him/them.

The licensee/ licensees shall not pay less than the minimum wage to the workers engaged by him/her/ them, and shall otherwise comply with the provisions of the payment under "Payment of Wages Act 1936" or any statutory modification or re-enactment thereof or rules framed there under.

- 26. <u>UNTOWARD INCIDENCE</u>: The Railway administration shall not be liable to pay any compensation to the public for any negligence of the licensee resulting in injuries or death. The licensee shall be bound to pay any claims arising out of such incidence as per Railway rules and shall also abide the decision of the Railway Claims Tribunal under section 124/A of The Railways Act 1989 or any other decision given by court of Law on this matter. The Licensee shall be responsible for any damage caused to Railway property arising due to the acts of omission or commission of the staff by the Licensee.
- 27. An agreement should be signed between Railways and Licensee within 10 days after the date of payment of Security Deposit and first six months licensee fee by the Licensee. Failure to sign the agreement within this stipulated period by the Licensee will be treated as

I/90100/2022 breach of contract with all attendant liabilities. The acceptance of the tender shall constitute binding contract between you and the Railway Administration until the formal agreement is executed.
