In respect of staff belonging to Headquarters offices the Departmental Officer concerned shall verify and forward the applications to SPO/IR so as to reach this office not later than **26.02.2024**.

The following conditions are to be fulfilled.

- 1) The employees who are drawing double transport allowance are only eligible to apply.
- 2) Preference to those employees who have not participated in the earlier camp and staff who are on verge of superannuation.
- 3) The selected employees are not allowed to bring his/her working/non-working spouse or any other family members to the camp under any circumstances.
- 4) The participants are only responsible for their belongings.
- 5) The campers are advised to bring their own meals plate, tumbler, bed-roll, personal kit, Medicines if any etc.
- 6) The campers should maintain discipline and co-operate with the organisers throughout the camp.
- 7) An amount of Rs.500/-towards Camp fee has to be paid by each camper irrespective of their Pay (Grade Pay and Basic Pay) and Pay Band.
- 8) Employees selected for the camp should submit their sanctioned leave application for the period of camp along with 3-AC privilege pass covering the route from working place to Thiruvananthapuram and back. The selected employees have to submit their passes immediately on releasing the eligibility list.
