Railway Board vide Authority referred as above has stated that reference has been received from Defense authority wherein they have mentioned about variation in the methodology for calculation of Tariff at different booking points i.e some booking points are giving break up of various charges whereas others are giving a consolidated amount, due to which they are facing difficulty in reconciliation. They have requested for standardization of tariff calculation.

The matter has been examined. In order to bring uniformity in tariff calculation, a format "Worksheet for calculation of tariff in case of Military Traffic" is enclosed herewith for the guidance of all concerned.
