Please refer to this office letter no. 2015/TG-I/10/DT dated 21,02. 2018 & 26.03.2018 on the subject quoted above forwarding therewith procedure order and operator instruction for H2H integrated terminal and to nominate DCM/ACM as nodal officer for overseeing the implementation of POS/H2H integration with PRS/UTS. However, issues for standalone POS at PRS counter s are still being reported to JRCTC in large number's due to feeding of wrong RR number, wrong mapping of POS/TID with Railways terminal, etc.

2. It is, therefore, desired that zonal Railways should switch over to POS derives on Host-to-Host (H2H) integrated mode at the earliest to avoid such issues and customer complaints. It is also desired that the pending refund cases on this account may be settled manually offline ic consultation with Bank. Further, details of total POS machines available, those integrated with UTS/PRS, number of pending refund cases on this account etc. may be sent to this office in the following proforma by 08.03.2021.
