Sub: Periodical Transfers-2020 of Railway Employees holding Sensitive posts
Reservation staff – Commercial Department – BZA Division.
Ref: CPO/SC's letter No.P (R)676/II dated 29.12.09.

Railway employees holding sensitive posts, including those who frequently come into contact with public and /or contractors/suppliers are required to be transferred every four (4) years as per the policy laid down by the Railway Board.

As per the instructions contained under CPO/SC's letter cited, the details of the employees who are working at the same place for more than four years as on 31.03.2020 in the Reservation Cadre of Commercial department of this division department are furnished in the enclosed Annexure "A". The employees who are due for retirement during the next two (2) years i.e. up to 31.03.2022 have been excluded from the list as per guidelines issued by CPO/SC.

Concerned supervisory officials are advised to notify the staff working under their control, under acknowledgement, that they are identified for periodical transfer in the month of March/April so as to enable them to plan properly about their children's education and also housing accommodation at new stations in the ensuing academic year. If, any omission / inclusion of names in the Annexure "A" in respect of employees who are also due /not due for transfer is found, the same may be informed to the undersigned along with relevant details/documents for further action.

And also the list of request transfers in the following categories of staff as per the priority register maintained in this office is enclosed Annexure "B" herewith for notifying the staff. The concerned supervisory officials may inform the position to concerned staff under acknowledgement.


