He was relieved from Admin section on 06.08.2024 (A/N) and reported this section on same day i.e. on 06.08.2024 (A/N) vide DPO/BZA's note under letter No. SCR/P.BZA/O.A/General/2024 dated 06.08.2024. He was posted in Sr. DCM/O/BZA against higher grade vacancy. Now he was relieved today i.e. on 17.09.2024 (A/N) with instructions to report to Sr. DCM/BZA immediately. The period from 06.08.2024 to 17.09.2024 is treated as duty waiting for posting orders.

The above promotion/Posting is provisional and subject to the terms and conditions:-

1. The employee is being free from DAR/SPE/Vigilance Cases pending / contemplated /criminal investigations in terms of instructions contained vide PCPO/SC's SC No.16/1993 and not undergoing any suspension & penalties debarring him from promotion.
2. The final outcome of ongoing litigations/courts on the subject.
3. Outcome of cases pending before various courts of law.
4. He was to qualify in the prescribed typing test (30 w.p.m) in English or (25 w.p.m) in Hindi within a period of 2 years of his posting failing which he is liable to reverted back to his original post as per extant instructions.
5. If the employee do not carry out the promotion/posting orders within 15 days, it will be deemed as a refusal and will be dealt accordingly as per the instructions issued vide CPO/SC's letter No. P/R/585/VI dated 29.04.2006 and letter No. P/R/605/11 dated 07.01.2008.
6. He is not eligible for exercise option, for fixation of pay in the promotional grade under Rule1313 FR (22) (1)(a)(i) of IREC Vol. II & CPO/SC No 107/2017 & 01/2020. Where as he was already drawing salary in L-3 under MACP.
7. He is eligible to draw higher rate of pay from the date of shouldering higher responsibility as Jr. Clerk in Level – 02 of 7th CPC Pay Matrix. The date of shouldering higher responsibility should be intimated to all concerned.
8. He will be on probation for a period of 12 months and his continuance in the higher grade will be subject to their successful completion of probation in terms of PCPO/SC SC. No. 175/2001.

9. They are not eligible for transfer benefits.
