Further to this office notification issued under letter of even no. dated 23.03.2021 & eligibility list published vide this office letters of even no. dated 29.06.2021 and 16.07.2021, a written examination in connection with above said selection is fixed to be held at 14.00 Hrs. on 29-08-2021 (Sunday) at ETTC and Kendriya Vidyalaya, Satyanarayanapuram, Vijayawada.

Accordingly, all the supervisory officials are advised to notify the above to all the eligible employees concerned communicated vide this office letters of even number dated 29.06.2021 and 16.07.2021, under their clear acknowledgement. All eligible employees should be relieved in time with proper individual relief-cum-identification letters, with instructions to report **by 12.00 Hrs. on 29-08-2021** either at ETTC/BZA or Kendriya Vidyalaya, BRTS Road, Vijayawada as mentioned below. The identity letter should contain the specimen signature and recent passport size photograph of the eligible employee duly attested by concerned supervisor. All eligible candidates should carry their identity cards issued by the competent authority and show the identity card on demand.

If, any of the eligible employees is on leave/sick/training the information should be sent to his leave/sick/residential/training address and his acknowledgement should be obtained and may be sent to this office. Since the selection is on volunteer basis, "there will be no supplementary written test for absentees under any circumstances". It is the prime responsibility of the In-charge/Senior supervisory officials concerned to intimate the contents of this letter to all concerned eligible employees and their relief. A copy of this letter should be placed on station notice boards. Concerned Supervisory Officials are advised to make necessary arrangements in place to the eligible employees and it is the responsibility of the supervisors to relieve them in time.

Para 3 of notification dated 23.03.2021 may be referred to in connection with the selection procedure. The candidates are not allowed to carry mobile phones and any other materials such as Electronic gadgets, course material etc.., with them in the examination hall except relief letter. Disciplinary action will be initiated against them, if found indulging in any unfair means and further debarring such candidates for future selection.
