The above orders are issued subject to the following terms and conditions:-

1. The postings are subject to their being free from SPE/DAR/Vig. Cases
2. The postings are ordered on their existing pay, Level and capacity in 07th CPC pay matrix.
3. The postings in PCCM/O/SC are on tenure basis. During the period of their service in the PCCM office, their lien will be maintained in their parent unit.
4. They shall be repatriated to their parent cadre any time without any notice, if their performance is not satisfactory during the period of working irrespective of their tenure period.
5. They will be repatriated to parent cadre at least six months prior to their superannuation.
6. They are eligible for transfer incidentals as per the extant rules.
7. They will continue to be governed by the provisions of the Indian Railway Codes & Manual and other extant orders as amended from time to time.

The above selection is subject to outcome of court cases pending before Hon'ble CAT/ High Court/ Supreme Court.
