The concerned supervisory officials are responsible to relieve the employees to carryout transfers. A copy of relief memo/joining report should be endorsed to commercial cadre section of this office without fail.

They should vacate Railway Quarters if any, under their occupation and handover Railway property, if in possession before they are relieved.
