The employees at S.No 1,3,4,5,12 & 13 are eligible for transfer benefits. They should be relieved immediately and the date of relief at old stations and the date of joining at new stations should be advised to all concerned.

The above employees can exercise the option for fixation of pay from the date of accrual of the next increment in lower grade under FR 22 I(a) (1). Such an option should be submitted to this office within one month from the date of issue of this office order.
